is hereby contracted to breed with the following Dam: _____

under the following terms:

The fee for the stud service must be paid **before the time of service** in the amount of **\$750.00**.

NOTE: The American Kennel Club takes the position that the owner of the sire is required to sign an application to register the litter certifying only to the fact that a particular dam was bred to the sire identified on the Litter Registration Application form on a specified date of mating, unless this is an agreement signed by all parties concerned in which it specifically set forth that the owner of the sire is not obligated to sign an American Kennel Club Litter Registration Application form until such time as the stud fee has been paid.

The owner of the Dam warrants that this Dam has not been exposed to any stud dog prior to her arrival and that she will be protected from such exposure after her return home.

The stud owner will breed the stud dog to the Dam with a minimum of 16-18 hours between breeding's.

If two or more puppies do not result from this breeding, a second stud service is available to the Dam at a later heat cycle, by the same stud dog, free of charge within one (1) year.

There is no charge for boarding the Dam for the first three (3) days, after which the charge will be \$25.00 per day. It is recommended that the Dam owner bring the Dam's own food while boarding. In the event that no food is provided by the Dam owner, a \$10.00 per day fee will be added for feeding the Dam the stud owner's food. During this time the Dam will be fed, watered, exercised, and cared for daily by the stud owner. The stud owner agrees to keep the Dam confined and inaccessible to all other male dogs until the Dam has been bred and returned to her owner. The Dam may also be brought to the home of the stud owner for two or three (2-3) days for breeding purposes and return home with the Dam owner each day.

The Dam owner hereby agrees that his or her Dam is cared for and handled by the stud owner without liability on the stud owner's part for loss or damage to the bitch from accidents, injury, disease, theft, fire, or other unavoidable causes of injury to persons, or other animals, or damage to the property caused by the Dam when due diligence and care have been exercised by the stud owner.

If need arises, the stud owner will provide veterinary care of the Dam. Except in an emergency, when the Dam owner cannot be contacted, the stud owner will consult with the Dam owner prior to any veterinary intervention. The Dam owner will reimburse the stud owner for any such veterinary expenses.

Dam owner agrees that Dam is healthy and **up to date on all vaccinations** and will provide the stud owner a copy of such veterinary records, including current rabies vaccination records. Dam owner must also provide a copy of AKC registration certificate. It is recommended for the Dam to have **OFA health clearances** for hips and elbows with a minimum rating of "good"; these records must also be provided at time of breeding if applicable. Dam owner agrees that Dam will not be sold, traded, or given away to a third party while carrying puppies.

To insure the owners of the Dam has read and does indeed understand the conditions of this contract as set forth herein, please sign and date below. DO NOT SIGN IF YOU DO NOT UNDERSTAND THIS STUD SERVICE CONTRACT.

In consideration of a Stud price of **Seven Hundred and Fifty Dollars (\$750.00)**, of which is non-refundable. This can be paid by cash or PayPal with 5% extra for PayPal fees.
